

**Assumption of the Risk and Waiver of Liability
and Photo & Video Release**

I, the undersigned, on behalf of myself and my below identified children (if applicable) ("collectively referred to herein as "I," "me," or "Participant"), hereby acknowledge and understand that in consideration of the acceptance of my participation and/or attendance in the Kenosha Robo Crew Practices (a Jockey STEM and Robotics Initiative) and/or Robotics Competition, (the "Event or Events"), do hereby waive and forever release Jockey International, Inc. ("Jockey"), Shoreland Lutheran High School ("Shoreland"), and all of their Designees assisting with or hosting an event, sponsors and their representatives, volunteers and employees (collectively the "Released Parties") for any and all injuries to me, my below identified children (if applicable) and my personal property. "Designees" includes those persons or entities (including third parties not affiliated with Shoreland and/or Jockey) managing, contracting, sponsoring or hosting a Kenosha Robo Crew Team practice and/or a Robotics Competition. "Participant" shall mean any individual, Parent/Guardian of below identified children (if applicable), student, mentor, teacher, volunteer, or other person or entity involved in one or more Events.

I, the undersigned, on behalf of myself and my below identified children (if applicable), acknowledge and understand that there may be risks associated with attending and/or participating in an Event. I, on behalf of myself and my below identified children (if applicable), assume all risks associated with attending and/or participating in an Event including, but not limited to, risks inherent in the construction and/or operation of robots, working with electrical connections, operating or handling tools or sharp objects, traveling to and from Events, and participating in and/or attending public competitions, and waive any and all claims which I and my below identified children (if applicable) might have based on any of those and other risks typically found with participating in and/or attending STEM and Robotics Events. I acknowledge all such risks are known and understood by me. I agree to abide by all decisions, rules and regulations of any Event official relative to my ability to safely attend and/or participate in an Event.

I, on my behalf and on behalf of my below identified children (if applicable), acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my family, children and I may be exposed to or infected by COVID-19 by attending and/or participating in an Event and that such exposure or infection may result in personal injury, illness, permanent disability and death. I understand that the risk of becoming exposed to or infected by COVID-19 during an Event may result from the actions, omissions, or negligence of myself and others, including, but not limited to, the Released Parties and their respective owners, employees, agents, volunteers and their families and guests. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF the Released Parties, their owners, officers, agents, employees, volunteers or others, and ASSUME FULL RESPONSIBILITY for my attendance and/or participation in an Event.

I, on my behalf and on behalf of my below identified children (if applicable), further hereby RELEASE, COVENANT NOT TO SUE, DISCHARGE AND HOLD HARMLESS the Released Parties from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity (including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto), which arise or may hereafter arise from my attendance and/or participation in an Event. I understand and acknowledge that this Release discharges the Released Parties from any liability or claim that I may have against the Released Parties with respect to bodily injury, personal injury, illness, death or property damage that may result from my attendance and/or participation in an Event. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to me and/or my below identified children (if applicable) including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that I or my children may experience or incur in connection with an Event.

Photo & Video Release

I consent to and authorize the use of my image (either still or motion picture), voice and/or likeness by Jockey International, Inc., Shoreland Lutheran High School or any of its affiliates through any media now and in the future relating to my participation in an Event. I understand that I will receive no compensation in connection with the use of my image, voice and/or likeness. Furthermore, (if applicable) I consent to and authorize on behalf of my below identified children the use of their image (either still or motion picture), voice and/or likeness by Jockey International, Inc., Shoreland Lutheran High School or any of its affiliates through any media now and in the future relating to their participation in an Event. I understand that they will receive no compensation in connection with the use of their image, voice and/or likeness.
