You warrant that Your Child’s Contribution will not infringe the copyright or similar rights, of any third party and that You have obtained all necessary consents and permissions for BBCGN and, our successors, licensees and/or assignees to be able to use Your Child’s Contribution. You will indemnify and hold BBCGN, our parent company, successors, licensees and assigns, harmless from and against any and all claims, damages, liabilities, costs and expenses arising out of any breach of the foregoing warranty.
5. You agree that no payment, residuals or sums are due to You now or in the future.
6. You agree that BBCGN may edit, add to, adapt, dub or translate Your Child’s Contributions and You waive irrevocably any so-called “moral rights” (or equivalent legislative provisions) You/Your Child may have in them.
7. You agree that BBCGN may (if relevant) without further consent use Your Child’s name likeness biography photographs of Your Child and recordings of interviews with Your Child in production and creation of, use,

14. This agreement shall be interpreted in accordance with English law and, in the event of any dispute, the Courts of England and Wales will have jurisdiction.
