1. PURPOSE AND DEFINITIONS. This Agreement supplements, and does not replace, the VEX Robotics Global Participant Waiver and Release of Liability. "RECAP" means **Robotics Education Competitions All-Inclusive Package**, the Event Partner organizing/conducting the competition. "SLT" means **Sunrise Love Travel**, the travel agency arranging certain cruise/travel services associated with Anchors Aweigh.

**NOTICE TO THE MINOR CHILD'S
NATURAL GUARDIAN**

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF ROBOTICS EDUCATION COMPETITIONS ALL-INCLUSIVE PACKAGE (RECAP) USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM ROBOTICS EDUCATION COMPETITIONS ALL-INCLUSIVE PACKAGE (RECAP) IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND ROBOTICS EDUCATION COMPETITIONS ALL-INCLUSIVE PACKAGE (RECAP) HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

3. RELEASE AND ASSUMPTION OF INHERENT RISKS. To the fullest extent permitted by Fla. Stat. § 744.301(3), I, as the minor's natural guardian, authorize participation and waive and release in advance claims against RECAP, its owners, affiliates, employees, agents, and authorized volunteers for personal injury, death, or property damage resulting from inherent risks of the activity. I understand such risks may include robot/equipment operation, tools, batteries/electrical systems, ship movement, stairs/decks, embarkation/disembarkation, crowds, transporting robots/equipment, and interaction with participants and attendees. Nothing here waives claims that cannot legally be waived.

4. SUPERVISION; ROYAL CARIBBEAN; SLT. RECAP and SLT do not assume general parental or custodial responsibility for a participant. The parent, school, coach, and/or designated chaperone remains responsible for appropriate supervision, especially outside official competition activities. Royal Caribbean controls the vessel, cruise transportation, accommodations, dining, medical facilities, itinerary, and ship operations under its own passenger contract and policies. SLT acts as a travel advisor/intermediary and does not operate or control the vessel or independent travel suppliers.

5. MEDICAL; RULES; ACKNOWLEDGMENT. If I cannot reasonably be contacted in an emergency, I authorize appropriate emergency medical assistance for my child and accept responsibility for resulting costs except to the extent covered by insurance or another legally responsible party. I agree the participant will follow VEX/RECF rules, Event Partner instructions, and Royal Caribbean safety/conduct requirements. I have read this Agreement, understand that it supplements the VEX waiver, and voluntarily authorize participation.
